Donation of CO₂ Reduction Credits to Tokyo Metropolitan Government

*The TMG’s Cap-and-Trade Program obliges large business facilities to reduce CO₂ emissions under the Tokyo Metropolitan Environmental Security Ordinance. If CO₂ emissions are reduced beyond the reduction obligation, CO₂ reduction credits will be generated, enabling businesses to make use of transactions.
